2. Duration of the contract

The beginning of the contract is _____ (dd/mm/yyyy). The contract has a duration of:

The contract may be terminated by either party at the end of the contract without giving reasons and in compliance with the applicable period of notice. Cancellation must be made in writing. The notice period is 30 days before the end of the contract. The deadline is the receipt of the notice of termination. If no written notice is given in due time, the contract is automatically extended by (further) 6 months.

The participating person is aware that during the breaks/vacations specifically set for the dance area (summer, fall, winter, spring), no classes will be held and the obligation to pay the participation fee will remain continuous during this time.

3. Fees

An administrative fee of 29,00 Euro is due on first signing of the contract. The fee is to be paid in cash or debited together with the first monthly instalment.

A participation fee of _____, ___ Euro per month is charged in the same monthly installments for ongoing courses or lessons.

The monthly installments are due on the 5th of each month and are debited *in advance* by SEPA direct debit on the due date. If the 5th of a month is not a bank working day, the due date shall be the nearest bank working day.

Should it not be possible to debit the participation or administration fees, e.g. due to lack of funds in the account or due to a chargeback, the participant shall bear the bank charges incurred. If the participant is in arrears with two monthly payments, the GMS is entitled to suspend the lessons immediately until payment has been made. The GMS has the right to demand outstanding amounts by legal action and to terminate the contract extraordinarily if the participant is more than 35 days in arrears with the payment of the fees. 5. Final provisions

Both contract partners are subject to aforementioned contract conditions throughout the term of the contract.

In case of a fee increase, due upon the extension of contract, these will be announced four weeks in advance by the GMS. A participant not wishing to pay the increased fees may terminate his/her contract without the normal deadline for cancellation. If the participant does not terminate the contract, GMS notifications regarding the new fees for the courses will become part of the contract.

GMS house rules apply without exception to all visitors and users of the facilities.

No verbal supplements or changes to this contract have been agreed upon. Any additions or changes and/or additional agreements to this contract must be made in writing.

The inoperativeness of one or several provisions of this contract does not affect the validity of the remaining provisions. In such case a provision is applicable which meets best the legal and economic aim of the inoperative provision.
